- 1.3 All prices are in euros (€) and include VAT, unless stated otherwise.

## 2. Ordering and Payment

- 2.1 Orders can be placed via stellaleather.com.
- 2.2 After submitting an order, the customer will receive a confirmation email. This confirmation does not guarantee acceptance; the contract is concluded once the payment is received and the order is dispatched.
- 2.3 Accepted payment methods will be displayed at checkout (e.g., credit card, bank transfer, PayPal).
- 2.4 The company reserves the right to cancel an order in case of stock unavailability or incorrect pricing.
- 3. Shipping and Delivery
- 3.1 Products are shipped within the European Union.
- 3.2 Delivery times vary depending on destination and will be communicated at checkout.
- 3.3 The company is not responsible for delays caused by customs, couriers, or force majeure events.

## 4. Product Information

4.1 Due to the handmade nature of our products, slight variations in color, texture, or stitching may occur. These are not defects but unique characteristics of artisanal craftsmanship.

- 4.2 Product descriptions and images on the website are for informational purposes.
- 5. Right of Withdrawal (EU Consumers)
- 5.1 In accordance with EU consumer law, customers have the right to withdraw from the contract within 14 days of receiving the goods, without providing a reason.
- 5.2 To exercise this right, customers must notify us at info@stellaleather.com within the 14-day period.
- 5.3 Customers must return the goods within 14 days of notifying withdrawal. The return costs are borne by the customer.
- 5.4 The product must be returned in its original condition, unworn, and with all tags attached.
- 5.5 A refund will be issued within 14 days of receiving the returned item. Shipping costs are non-refundable.
- 6. Returns and Exchanges
- 6.1 If you receive a defective or incorrect product, please contact us within 7 days of delivery at info@stellaleather.com
- 6.2 We will provide instructions for return or exchange.
- 6.3 In the case of defects, the company will cover return shipping costs and provide a replacement or refund.
- 7. Warranty
- 7.1 Our jackets are handmade with high-quality materials. Products are covered by the statutory 2-year EU warranty against manufacturing defects.
- 7.2 This warranty does not cover normal wear and tear, accidental damage, or improper care.

- 8.1 Customer data is processed in compliance with GDPR and Slovenian data protection
- 8.2 Personal data will only be used for order processing and communication.
- 9. Governing Law and Disputes
- 9.1 These Terms are governed by Slovenian law.
- 9.2 Any disputes shall be resolved amicably; if not possible, they fall under the jurisdiction of Slovenian courts.
